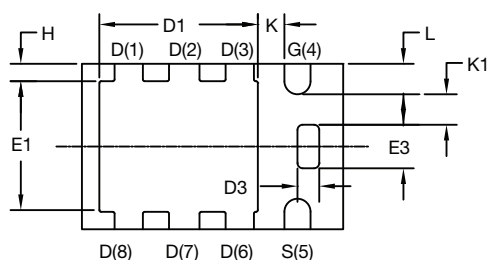
Side view of single



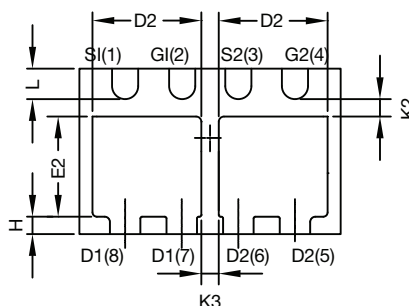
Side view of dual

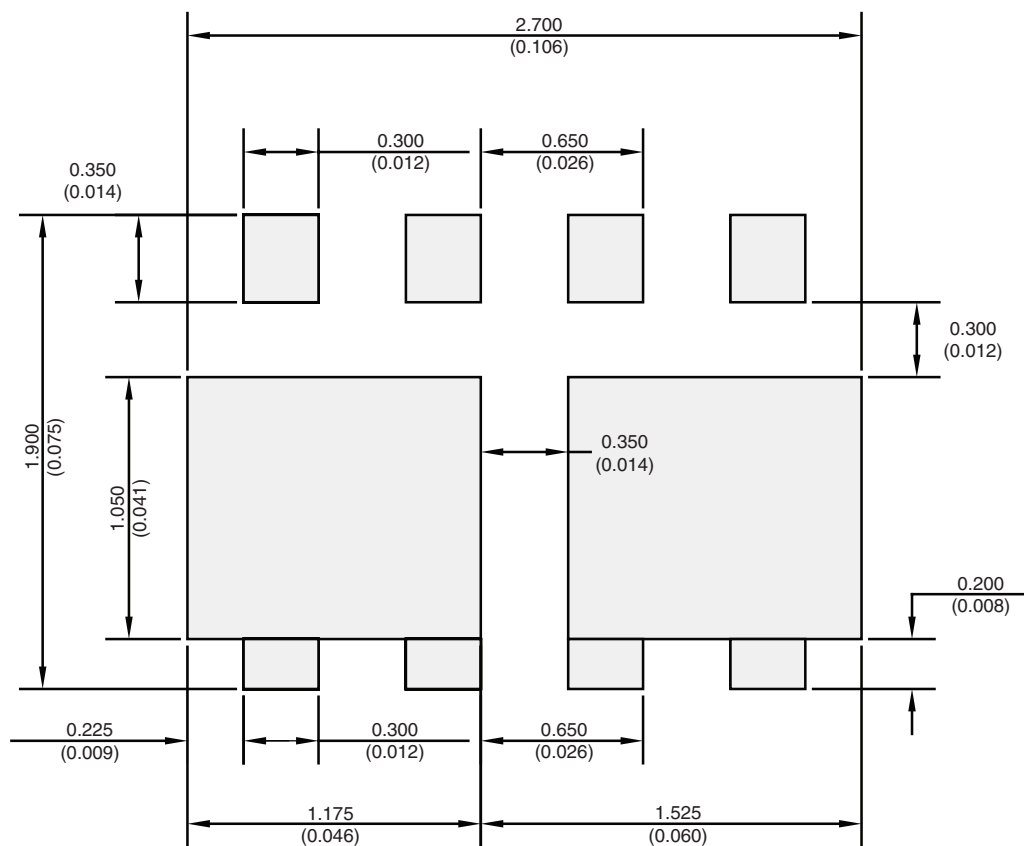
